

## **Advancing Financial Literacy and Performance in the Veterinary Profession**

Terry O'Neil and his team from Katz, Sapper & Miller have earned a prominent position in veterinary economics. Their presentations – at the AVMA Veterinary Economics Summit and Veterinary Study Groups meeting, for example – are highly anticipated for the breadth of understanding the team possesses about how to help veterinary practices reach optimal financial performance. They deliver critical insights around tools for veterinary practices to use, including key performance indicators and the five financial categories every practice should track.

You'll learn about how pet savings accounts differ from wellness plans, how a VMA can promote models of independent practice ownership that can work with the preferences of new graduates, and how helping retiring veterinarians (of which there are about 10,000, Terry says) think about succession plans and their legacy might lead to outcomes different from selling to a consolidator.

In addition to understanding veterinary economics at a granular level, they also comprehend the broader strategic environment in which today's veterinarians must function – and they appreciate the role that veterinary medical association executives can play in creating an environment in which members can prosper. You'll interact with Terry and the team in exploring pressing questions like these:

- How can a VMA teach its members financial literacy?
- What does a VMA executive need to know about veterinary economics?
- How can a VMA help its members achieve financial success?
- How can a VMA educate on the challenges facing their hospitals and the veterinary profession as a whole?
- What are the trends and indicators telling us about where is the veterinary industry heading?

Dr. Green has a special interest in the future of veterinary medicine and the innovations that will help ensure a thriving profession.
