1:00 - 2:00 PM	License Mobility and Portability Dr. Kelly Cooper, Chair, Working Group, AVMA Council on Veterinary Service Jim Penrod, Chief Executive Officer, American Association of Veterinary State Boards Each state, territory, and province have a different process for granting veterinary licensure. Confusion in the application process can delay or prevent a veterinary professional's ability to work in some jurisdictions. In this discussion, we review license portability and mobility along with the challenges and possible solutions that can make licensing more accessible. We examine the AAVSB's license mobility services and how states and territories can utilize a new central database. We also receive an update from an AVMA working group studying this issue and developing recommendations.

Doug Raven



Doug Raven served as the CEO of the Ontario Veterinary Medical Association (OVMA) from 1998 to 2001. During his tenure, OVMA established a North America-wide reputation for leadership and innovation. The association placed a particular emphasis on encouraging veterinary practices to embrace customer-facing technology, including online stores, real-time appointment booking, and telemedicine.

One of Doug's many initiatives during his tenure at OVMA was the creation of the Farley Foundation, which has raised over \$12 million and assisted 14,000 low-income pet owners pay for veterinary care for their beloved pets. Since retiring from the OVMA, Doug continues to be active within the profession, facilitating strategic planning and governance projects for state, provincial and national associations across North America.

Amber McCoig, DVM, MPH



Dr. Amber McCoig is a Senior Veterinary Medical Officer, Science Policy, at US FDA Center for Veterinary Medicine (CVM). Dr. McCoig has been with the FDA for fifteen years beginning in the Center for Food Safety and Applied Nutrition (CFSAN). For the last decade, she has worked on veterinary public health policy issues for CVM with a focus on human food safety, drug residues, antimicrobial stewardship, and unapproved drugs. Dr. McCoig has served in various capacities for CVM including the Deputy Director for CVM's Division of Compliance.

Before coming to the federal government, Dr. McCoig worked in clinical veterinary practice. She earned a Bachelor of Science and Doctor of Veterinary Medicine from the University of Missouri and a Master's in Public Health from Johns Hopkins University with a focus on Public Health Policy Communication.

Lori M. Teller, DVM, DABVP (canine/feline), CVJ



Dr. Lori Teller is a graduate of Texas A&M University College of Veterinary Medicine (TAMU VMBS), and is a board-certified diplomate of the American Board of Veterinary Practitioners in Canine and Feline Practice. She has worked at Meyerland Animal Clinic for many years, starting at the age of 12. In 2018, Dr. Teller joined the faculty at TAMU VMBS as a Clinical Associate Professor. She is very passionate about her teaching role, as well as telemedicine and its utilization in the veterinary field. She and her colleagues were awarded a grant from the USDA to explore the role of telemedicine in veterinary education, and a grant from the Petco Love Foundation for a program to improve access to veterinary care for low-income,

elderly pet owners in a rural Texas community. She has authored several articles on veterinary telemedicine, as well as many articles related to primary care services. Dr. Teller is currently the President of the American Veterinary Medical Association and has a monthly radio spot in Houston, Texas discussing veterinary care for dogs and cats. She continues to mentor veterinary students, graduate students, recent graduates, and rising leaders. She married her high school sweetheart, has a son, and several pets.

Jessica Vogelsang, DVM, CVJ



Dr. Jessica Vogelsang is a veterinarian, international speaker, bestselling author of *All Dogs Go to Kevin*, and Chief Medical Officer at AAHA. As the founder of Pawcurious Media back in 2009, she was one of the first veterinarians to explore how the internet was going to impact the profession and build community. In that time she reached hundreds of thousands of pet owners around the world, helped launch multiple veterinary brands, and created the Veterinary Telemedicine community in response to COVID-19. In addition to her work at AAHA, she currently sits on the boards of the Mark Morris Institute and the Veterinary Virtual Care Association.

Nicole Rogers



Nicole Rogers is a veterinary technician who has been working with animals for over 10 years and has been an animal lover and pet owner throughout her life. Her experience in the animal care field includes working with cats, dogs, and even wildlife. In addition to working in the traditional veterinary medicine field, she also has developed skills in alternative medicine for pets.

Nicole managed veterinary practices in the Philadelphia, Pennsylvania area, appeared on television and web series segments about pet care, and co-hosted a cat health radio show, all in addition to her volunteer work with local animal shelters and a wildlife rehabilitation clinic. On her own convictions, she even worked with park rangers to safely capture, rescue, and find homes for domestic animals illegally released in national parks.

Heather Prendergast, RVT, CVPM, SPHR



Heather Prendergast has spent over 30 years in the veterinary industry, with 20 years in small animal practice. She has taught several years for both veterinary technology and assistance programs and has authored the book *“Front Office Management for the Veterinary Team”*, now in its 3rd edition. Heather has also authored the book *“Review Questions and Answers for Veterinary Technicians”* that are preparing to sit for the VTNE, now in its 6th edition.

Heather is well known and lectures nationally and internationally and has authored several articles with the goal of developing leadership and culture in practices while employing appropriate team leveraging to increase efficiency and enhance the ‘flow of services’ in the veterinary practice. When she is not lecturing, writing, or consulting, she volunteers for industry groups, and serves as a Director for NAVTA, Secretary for the Pet Nutrition Alliance, and as Vice President for the Viticus Group (formally known as WVC) Board of Directors.

Veterinarian and educational psychologist Dr. Julie Noyes is one of the leading educationalists working in academic veterinary medicine.
